Beth stated that there are currently four families on e-scrip and had an informational pamphlet for people interested in e-scrip. There was discussion on why so much money was going to the general fund and not to individual student accounts. Mark Boyer explained that when you swipe your card at Von's, half of the amount goes to the student and half goes to the student accounts. The Talon's is most likely getting credit from former students and families

Old Business:

Big Red/ Gator Update:

Mark Boyer: no new information on the gator

Mark Boyer will check on the breaks on Big Red

Bob Lenau will contact Bill to move Big Red in order to get uniforms and supplies out

PA system update/financial assistance from ASB

Ed Smith has repaired the Behringer Intrument amp

Clarification from Meagan Holmes over the option of drum majors to approach ASB for funding of PA system

Mr. Ouska will work with drum majors Sarah Lenau and Charles Cummins to contact Mrs. Porter and ASB for financial assistance in order to purchase a new PA system.

Audit:

Mark Boyer stated that the bylaws ask for an annual budget. There has not been an audit for 3 years

Jane Smith gave a name of a contact from CPA Rick Phillips at the May board meeting

Beth Lenau will contact Terry Stone before the next general meeting

Budget:

Possible Band fees cannot be set until Mr. Ouska meets with the administration to discuss the budget for the band program. Meagan Holmes stated that fees would run from \$300-350. This information was received from Nicole Despot. The cost will depend on school budget, busses for out of town travel, and purchase of new warm ups.

Mr. Ouska requested examples of the school warm ups from the last 3 years before he can make the decision on warm ups

Mark Boyer and Beth Lenau will send the warm ups for the last three years to band camp for Mr. Ouska to inspect and decide

Group asked Mr. Ouska about what type of purchases will be needed for this school year. Mr. Ouska felt more instrument maintenance will be needed rather than large purchases. He may be in need of two large speakers for practice.

Ed Smith: Talon's already have two 15 inch speakers with horn. He is willing to fix for \$50.00 per speaker.

Jimmy Talleferro requested the purchase of 5 harnesses for percussion. He had found them on line for \$208.0. The Talon's Board will look into the purchases.

Getting uniforms out of Big Red/Today Cleaners:

Big Red needs to be moved as soon as possible

Jane Smith will contact Michelle Bateman to find out which Today Cleaners the uniforms are to be delivered to (uniforms picked up 8/18/09)

Group discussion over which uniforms need to be cleaned and fittings/possible alterations. Leah Oats and Kelley Hoover suggested fitting the students before cleaning. Beth Lenau and Jane Smith stated that Mr. Campos had a computer program that would help in sizing students and reduce the volunteer times

Mr. Ouska will look for the computer program and pick the dates once he knows when the uniforms will be back from the cleaners.

New Business:

Date of car wash changed from Sat., August 22nd to Sat., August 15th from 7:00 am – noon

Keeping the cost of tickets at \$5.00 each and each band member is responsible for selling 6 tickets. Mr. Ouska requested extra tickets for him to use.

Mark Boyer will print and number the tickets and have them ready by the first day of band camp (August 10th)

Discussion of where profits of the car wash should go: Talon's account or individual student accounts

Motion: Profit from the sale of pre-sale tickets will go to the individual student accounts. Tickets sold the day of the car wash and the money in the tip jar will go to the Talon's general fund

Bob Lenau motioned to approve the division of car wash funds

Planning for Music in Motion (11-21-09):

A permit from the city of Bakersfield is needed to close off both Hagemen and Riverlakes on the day of the event. The Talons needs to get a certificate of insurance from Walter Mortensen for the city.

Mark Boyer will get the certificate from Walter Mortensen and Leah Oates will take care running the paperwork to city offices.

Mrs. Simpson requested donations to the Talon's organization in lieu of flowers in memory of her husband.

First planning meeting for MIM will be on Tuesday, September 8th at 6pm in the band room before the general meeting begins at 7pm.

Group suggested handing out information on MIM at the band potluck on Friday, August 21 at 6pm.

Mark Boyer will get an informational sheet prepared for the potluck

Fundraising: Suggestions/Ideas:

Kathy Villa had information on possible donation from Starbuck's to use as an auction item at MIM.

Kathy Villa will get the tax ID # for the Talon's organization from Nicole Despot and submit request to Starbuck's

Group raised concerns about auctions looking like gambling at MIM. Group can double check the parameters during MIM planning meetings.

Meagan Holmes gave a brief overview of meeting with fundraising company Majestic Family Savings. Options for fundraising included cookie dough, selling pies from Marie Calendar's, and discount card. The Talon's are committed to selling cookie dough beginning Friday, September 4th. A contract had already been signed by Mr. Campos. MIM and PPAACC are other options for earning money

Mr. Ouska will place the Centennial Band in the lottery for PPAACC in the spring.

Purchase orders/Requests for money for supplies:

Clarification from Mark Boyer over the policy when purchases can be made

\$500.00 and under: Talons Board approval

\$500.00 and over: Vote at general meeting

Since Nicole Despot unable to attend meeting, board members present did not have a clear picture of finances and budget for the Talons. Kelley Hoover also explained we had receipts showing up late in the school year that still needed to be accounted for. Mr. Ouska suggested setting budget and set allotments in certain categories and would know more after meeting with Centennial administration. Mark Boyer wanted to refine ideas or proposals once we have a definite budget. Above all, there needs to be more accountability.
